ASSENTED-TO MOTION TO EXTEND DEADLINE TO FILE RESPONSIVE PLEADINGS

NOW COMES Defendant, Trini Brassard (“Ms. Brassard”), by and through her attorneys, Brannen & Loftus, PLLC, and hereby files this *Assented-to Motion to Extend Deadline to File Responsive Pleadings*, requesting that this Court extend the deadline for Courtney Brassard to file her responsive pleadings in this matter to Tuesday, September 5, 2023. Ms. Brassard is filing this assented-to motion on behalf of Todd Steadman, Esq., and his client, Courtney Brassard, as Attorney Steadman has been responding to a family medical emergency since the morning of August 29, 2023, and is unable to file this request. In support, Ms. Brassard states as follows:

1. On August 15, 2023, Plaintiff filed a *Stipulation of Parties*, setting a deadline of August 29, 2023, for all Defendants to file their responsive pleadings in this matter. The Court issued an order approving the stipulation on August 17, 2023.

2. On August 29, 2023, the undersigned was contacted by Todd Steadman, Esq., counsel for Courtney Brassard, who stated that he was at the hospital responding to a family emergency and would be unable to file Courtney Brassard's responsive pleadings by the August 29 deadline.
3. Ms. Brassard, on behalf of Attorney Steadman and his client, Courtney Brassard, respectfully requests that the Court extend the deadline for Courtney Brassard to file her responsive pleadings to Tuesday, September 5, 2023.
4. Elizabeth Willhite, Esq., counsel for Plaintiff, and Todd Steadman, Esq., counsel for Courtney Brassard, were contacted and have provided their assent to the relief requested herein.

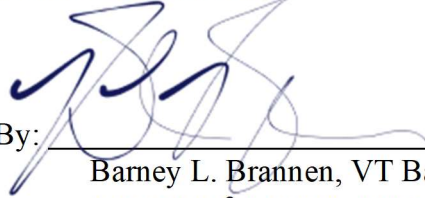
WHEREFORE, Trini Brassard respectfully requests that this Court:
